### **PCs in bargaining: Unlawful yet again!**

The Manitoba Government and General Employees' Union (MGEU) recently announced that the Court of Appeal has confirmed that the union had a right to have an interest arbitration board appointed to determine the terms and conditions of the next Civil Service collective agreement.

In summer 2019, MGEU's Civil Service Bargaining Committee exercised its right under *The Civil Service Act* to file for arbitration. However, instead of following the *Act*, the Minister refused to proceed with the arbitration process, claiming that he had discretion not to, and that the union's request was premature.
